Current Appointments: Professor of Infectious Diseases and Epidemiology at the University of Texas – Houston School of Public Health, the Mary W. Kelsey Chair in the Medical Sciences at the University of Texas McGovern Medical School, Clinical Professor, Baylor College of Medicine, Adjunct Professor, MD Anderson Cancer Center, Professor, the Graduate School of Biomedical Sciences at University of Texas and MD Anderson Cancer Hospital, and Adjunct Professor, the University of Houston School of Pharmacy.

Dr. DuPont received a BA in chemistry from Ohio Wesleyan University and an MD from Emory University School of Medicine. He completed internal medicine training at the University of Minnesota Medical Center and infectious diseases fellowship at the University of Maryland. He served as an Epidemic Intelligence Service Officer at the Centers for Disease Control and Prevention (CDC). He received an honorary doctorate from the University of Zurich (Switzerland) and an honorary Doctor of Science from Ohio Wesleyan University.

Dr. DuPont served as President of the Infectious Diseases Society of America, the National Foundation for Infectious Diseases, the American Clinical and Climatological Association and was the first President of the International Society of Travel Medicine. He served on the Board of Governors for the American College of Physicians (ACP) and served as ACP Governor for south Texas.

He served on the Editorial Board of medical journals in infectious diseases and gastroenterology, served on the Vaccines and Related Biological Products Advisory Committee of the FDA and the Board of Scientific Counselors of the National Center for Infectious Diseases at the CDC. He is a member of the American Society for Clinical Investigation, the Association of American Physicians, and the American Epidemiological Society.

Honors received by Dr. DuPont include: Distinguished Achievement Citation from Ohio Wesleyan University; the Distinguished Medical Achievement Award from Emory University School of Medicine; the Bronze Medal of Honor from the French Government for his work to help create the field of travel medicine; the Maxwell Finland Award for Scientific Achievement from the National Foundation for

Infectious Diseases; Mastership in the American College of Physicians; the Alexander Fleming Award for Lifetime Achievement in Infectious Diseases from the Infectious Diseases Society of America; the President's Scholar Award for Research from the University of Texas Health Science Center, and the University title "President's Scholar"; the Founder's Award from the International Society of Travel Medicine; and from the University of Texas System, he received the Regents' Outstanding Teaching Award and was given the system title of "Distinguished Teaching Professor". He has authored or co-authored 774 publications (413 original science articles and 361 review articles or book chapters) and written or edited 19 books.
