# Contact Accounting Aid Society

- No cost tax, year-round tax preparation assistance is available for households earning less than \$58,000 a year;
- More than 120 volunteers served 11,600+ households;

- Average of \$1,800 refund per household

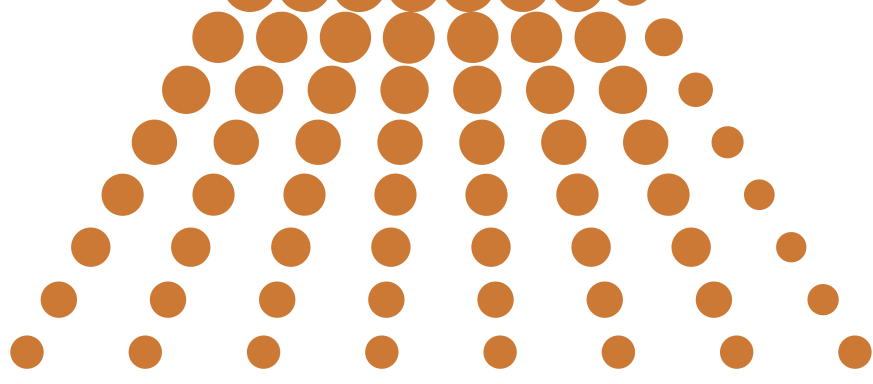

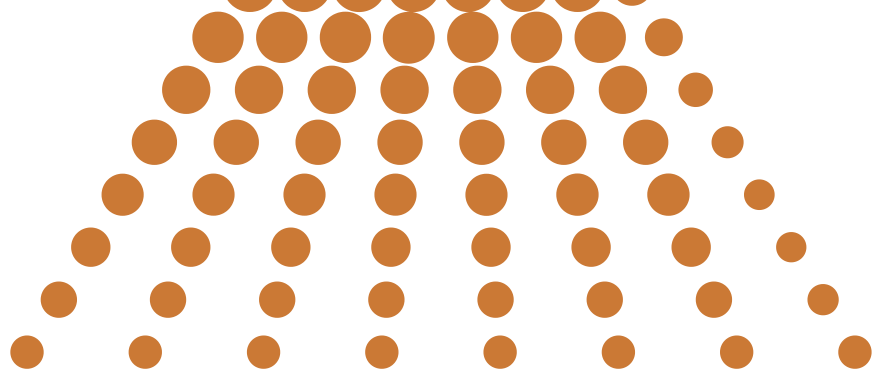
