


High - Risk Negative Co-Op

 Caseload of 9 enrolled, highly engaged clients, light touch based work with many others

 Some voucher holders, most looking for project based subsidies

 Most HIV-, are clients of AAC through the Access Drug User Health Program





A Day in the Life

- Housing Search Groups drop in hours for Access clients to ask housing questions, fill out applications
- Client meetings
- Connecting clients with services and agencies to help with housing search
 - C-CAN, Cambridge Multi-Service Center, HomeStart, CASPAR Outreach Services
- Complete and collect necessary documentation and paperwork
- Act as liaison between clients and PHAs or landlords
- Accompany clients to apartment viewings and screening interviews

HRN Successes & Challenges

- Clients are not eligible for AAC funding and programs, have to find other resources
- Facing barriers in communication, documentation, and transportation
- Challenges in working with clients who are using drugs, have mental health issues, or are dealing with large amounts of trauma
- Working within the harm reduction model when the rest of the world does not
- High levels of emotional labor

Reflections

- Didn't know anything about housing going in, now have a good grasp of how it works
 - Agencies and housing authorities, vouchers, tenant rights
 - Can now see the barriers and flaws in the system
- The importance of harm reduction
- Learning to not take work home with me
- Knew this was population that I wanted to work with, and wanted to try
 a position with more direct service


Voucher-Based Housing Search Co-Op

- Caseload of 17 clients, all of them are HIV + and Section 8 voucherolders
 - Boston Housing Authority
 - Metro Housing Boston
- Some newly issued vouchers with upcoming expirations, some with vouchers not on the clock

A Day in The Life

- Review emails and voicemails, call back clients
- Client meetings
 - Let the leasing officer know the client is looking to move, make sure they are not breaking their lease
 - Search online, call landlords, set up viewings
 - Attend viewings apartment viewing guide
 - Apply, submit an RFTA to their leasing officer if approved
 - Depending on the PHA, either the leasing officer or the landlord initiates the inspection process
 - If the unit passes, the tenant must sign a lease and bring updated income for their rent share to be determined
 - PHAs cannot pay two landlords at one time!
- Housing Search Groups market search on computers

Financial Assistance


- Rental and moving assistance applications
 - Security deposit and client's portion of the first month's rent
 - Moving expenses
- Amazon for cleaning supplies, sheets
- Bob's Card for mattresses
- Furniture banks (once in a lifetime)
- Boomerangs \$25 certificate





VBHS Reflection

- Hoped to have client interactions, field experience, and see Boston's geography
- Prefer open communication and mediumlevel of structure
- Independence
- Two certifications & three trainings



VBHS Reflection, continued

- Engaged with legal services
 - Sealing a CORI, working with notaries
- Shared my interests in housing and health (policy!)
 - Managed our relationship with the Suffolk Law Housing Discrimination Tester program
 - Meeting with the executive director of AAC about housing policy



VBHS Successes and Challenges

Most difficult/challenging

- Client facing eviction in two weeks, did not read or write so met every other day until we could sort out what we can do
- Landlord refused to work with us in the beginning
- Ended up paying his back rent in the "cure period" so it didn't go on his record and hand delivered the check

Strengthened organizational skills

50 page relocation packets, updated client files, data entry

Most exciting

- 3 moves on 12/1, 1 on 1/1
- Reporting a case to the Suffolk Tester Program

Client Challenges

- BMC methadone policy
- Lack of safe injection sites
- Transportation's impact on services
 - Access based on location, cost, mobility
- Communication's impact on services
 - Not having phone/internet access
 - Language barriers

- Lost/stolen documents or identification
- Discrimination (against various identities)
- Urban development by universities
 - Northeastern, UMass, Suffolk
