Ali Krieger is a professional soccer player, two-time World Champion, and Penn State Forward candidate. She is a fierce advocate for gender and LGBTQ+ equality and fair workplace conditions.

Ali graduated in 2007 with a bachelor's degree in Advertising and Public Relations. As a three-time Big Ten Academic Honors recipient, and co-captain (2005) and captain (2006) of the women's soccer team, Ali inspired people with her resilience and leadership. While a broken leg and life-threatening injury prevented her from finishing her junior season, she returned stronger as a senior: She won Big Ten Defensive Player of the Year, became the only Nittany Lion named an All-American at two different positions, and led the team to their fourth consecutive Big Ten championship win. Ali regularly returns to Happy Valley to support Penn State Athletics and speak with students.

Ali currently plays for Gotham FC. She has appeared in 108 US women's national team games—winning two World Cups and representing the US at the Olympics. With the USWNT, she filed a 2016 wage-discrimination lawsuit against the US Soccer Federation, which secured equal pay for USWNT players in the resulting historic 2022 collective bargaining agreement. Her peers elected her in 2018 to the USSF Athlete Council to represent them at the highest level. Since 2019, she's promoted LGBTQI+ equality as an Athlete Ally Ambassador. The Penn Stater Magazine featured her in 2021, with a cover story: "A Category All of Her Own."
