- PrEP-Rx aims to educate health care providers on PrEP and assist providers in the appropriate targeting of patients at increased risk for HIV, initiating PrEP when appropriate, and providing guidance on the ongoing monitoring and adherence counseling of patients on PrEP-also has helpful tools/patient handouts.
