- a. SR5 A Resolution Expressing Student Concern Regarding ACCESS
 - i. Author(s): Parliamentarian Kevin Durden
 - ii. Sponsor(s): Programming Committee Chair Abigael Villeneuve, Senate Ambassador Bethany Mueller, and Campus Life Committee Chair Sydney Stewart
 - iii. Authorship Report:
 - 1. The bills for the ACCESS initiative would harm students. I hoped official action by ASG wouldn't be necessary. The Arkansas ACCESS Act (HB1512 and SB246) is a set of educational reform bills that would significantly impact students
 - 2. Key provisions in Section 47 would prevent state-supported higher education institutions from granting excused absences for political protests, social advocacy, or efforts to influence legislation, restricting students' ability to participate in advocacy work
 - 3. Section 48 also aims to prohibit compliance with Diversity, Equity, and Inclusion (DEI) accreditation requirements, which could lead to the loss of accreditation for several degree programs and limit federal funding for universities. These changes are seen as harmful to students' rights to free expression and educational opportunities
 - 4. The resolution states that Associated Student Government Senate strongly opposes the bills in their current form and advocate for amendments that would protect students' ability to engage in political and social advocacy, support DEI initiatives, and preserve accreditation and funding
 - 5. The resolution also states the Senate Leadership Council will draft a letter to the Fayetteville General Assembly Representatives expressing the Senate's opposition to the Arkansas ACCESS bill in its current form and expressing the Senate's support for the amendments specified in the Resolution

This Letter and Resolution shall be sent digitally and physically to the Arkansas General Assembly"
 - 2. Adding: "The Senate will make the letter available to any agent of ASG to cosign prior to its being sent, digitally and physically to the state legislature"
 - 3. Adding: "Associate Vice Chancellor for Governmental Relations Rebeca Haley"
